We can help promote your organisation as well as volunteer opportunities, through outreach events and social media. You will be invited to attend an annual Networking event for Local Supporters alongside the AGM in July.

Resources to hire

We hire out lap tops, a digital projector and screen, display boards and flipcharts, along with offering in-house copying and binding services. We also have a small meeting room with refreshment facilities for hire. Local Supporters can hire our meeting room for only £5/hour (seats 8 boardroom style), get 50% reduction on South Hams CVS equipment use & loan, & discounted rates on bulk photocopying too. And, we offer one day hire of a set of display boards for free each year.

South Hams CVS Voting rights

As a Local Supporter your organisation will be entitled to a vote at South Hams CVS General meetings and so influence the way we function. The vote must be cast by a named representative.
